Ramblings from the Prez ...

So, where is that sanctuary you promised?

Almost two years ago, the idea of a Peoria Audubon Sanctuary started to form. Since then, the idea has grown into an initiative. A small group of volunteers has met every few months to discuss their visions for a sanctuary. We have gone through the slow process of convincing ourselves that it is something worth doing and have formulated a basic plan for achieving the goal.

Last March, we kicked off fund-raising with a Dessert Social and Auction. The event, along with a mailing this fall, raised \$7000 for the initiative. I can't tell you how encouraged I am by this. Since the majority of this has been in \$20, \$50, and \$100 contributions, it tells me there is broad support for the effort.

We have been very encouraged to see new areas preserved and restoration plans put in place to protect thousands of acres in Central Illinois. The Nature Conservancy's project near Havana and The Wetland Initiative's project near Hennepin are major steps toward protecting and restoring wetland systems along the Illinois River. It is our hope that we can make a modest contribution right here in the Peoria area by creating a sanctuary for birds and birdwatching.

Currently, we are looking for the right property to come on the market or be donated. We are trying to position ourselves to take advantage of any appropriate local, state, and federal programs and grants when this happens. Please let us know if you have ideas or would like to help in any way. Also, please join us on **March 13th** for our second Dessert Social and Auction to help us continue toward this goal.

National: Drilling in the Arctic National Wildlife Refuge

As of March 1st, the U.S. Senate debate on drilling in the Arctic National Wildlife Refuge had not begun. Last month, nature photographer Ken Madsen visited Peoria with a firsthand account of the beauty of this pristine wilderness. At our February meeting, National Audubon Grassroots Coordinator Kristen Berry outlined the many threats drilling poses to the unique arctic ecosystem and presented a compelling case for making your voice heard. Illinois Senator Peter Fitzgerald remains undecided and will be a key vote on the drilling issue. If you oppose drilling in the refuge, **call the capital switchboard at 202-224-3121** and ask for Senator Fitzgerald's office. Make the call even if you have called or written before. Leave a message asking the Senator to oppose drilling in the refuge. It takes less than a minute, but it can make a world of difference.

Regional: Army Corps of Engineers Navigational Study

The contentious Army Corps of Engineers Upper Mississippi River Navigation Study (which includes the Illinois River) has been restructured based on recommendations by the National Academy of Sciences. The Corps will be presenting an overview of the new study in a series of open houses. The first one is in Peoria on March 12th. It is critical to show up and urge the Corps to include ecosystem restoration as a key component of the plan. Let them know that wildlife habitat has a strong constituency in Central Illinois.

State: Development of Plum Island

Plum Island, located in the middle of the Illinois River across from Starved Rock State Park, is an important area for wintering Bald Eagles. Its owner is currently seeking annexation from the village of Utica to build a variety of town homes. This is scaled back from earlier plans to develop a hotel-marina complex, but remains a serious threat to the eagles. The Department of Natural Resources and the local State Senator, Patrick Welch, both oppose the development. At Starved Rock Eagle Days, Peoria Audubon participated in a booth that generated over 850 postcards to Governor Ryan requesting that he permanently preserve the island.

Write Governor Ryan at 207 State House, Springfield, Illinois 62706 and ask him to take action. Also consider attending the Native American Prayer Vigil the afternoon of March 24th to see the area under threat and learn more about the issue.

Local: Chautauqua Planning Process

On February 27th, the Illinois River National Wildlife Refuge held an open house at Dickson Mounds to gather public comments on an early draft of its long-range plan. The plan includes numerous provisions to improve biodiversity on the refuge, setting goals to increase habitat for grassland, savannah, and wetland birds. It does not, however, specifically mention shorebirds. The plan emphasizes the need for more public access, but includes no specifics. If you have comments on the long-term goals for the refuge, or thoughts about how to improve public access, **send them to U.S. Fish & Wildlife Service, Bishop Henry Whipple Federal Building, 1 Federal Drive, Fort Snelling, Minnesota, 55111-4056**. When sending comments reference the Illinois River Comprehensive Conservation Plan and ask to be notified when the final plan becomes available.

102nd Christmas Count Brings New Species, Highs

Central Illinois birders volunteered around 500 hours to make this year's three Christmas counts possible. The mild weather made things enjoyable for birders on the Peoria area count held December 15th, which racked up a healthy 75 species of birds. Rainy weather put a damper on the Chautauqua count held December 23rd, but the intrepid participants still located 85 species. By January 5th, colder weather and partially frozen water challenged the Chillicothe counters who managed to locate 64 species.

Bert Princen, Peoria count compiler, extends his thanks to the almost-record 26 participants – especially those who joined a Central Illinois count for the first time. The biggest news on the Peoria Count was the first appearance of Eurasian Tree Sparrows. Birders who regularly visit Banner Marsh and other Fulton County sites knew it was only a matter of time before this species crept north into the Peoria area. Record high counts, many attributable to unseasonably mild weather, include Pied-Billed Grebes,

Green-Winged Teal, Wild Turkeys, Rock and Mourning Doves, Red-Bellied Woodpeckers, Eastern Bluebirds, Yellow-Rumped Warblers, White-Crowned Sparrows, and American Goldfinches.

Although the Chautauqua count circle didn't include any new species, there were an astounding number of high counts. This year, Pied-Billed Grebes, American White Pelicans, Greater White-Fronted Geese, Hooded Mergansers, Ruddy Ducks, Wild Turkeys, Bonaparte's and Ring-Billed Gulls, Eastern Bluebirds, and American Robins all reached record numbers. Nine of these ten high count species were lingering migrants. Interesting count week species included a Black-Crowned Night Heron and a Long-Tailed Duck (formerly known as an Oldsquaw). Compiler Richard Bjorklund thanks everyone who helped make the count such a success.

The Chillicothe count also included new high counts for Snow Geese, Gadwall, Common Mergansers, Pileated Woodpeckers, Eastern Bluebirds, and House Finches. Compiler Tracy Fox thanks all who participated and all who scouted territories in advance. One scouting party located a Glaucous Gull, which added a new species for the count.

If you've never volunteered, think about joining us next year. Tentative dates are December 14 and 21, 2002 and January 4, 2003.

Central Illinois Weekly River Bird Census:

March 1st marks four full seasons of data for the census. For year two, the effort has been scaled back to one route per week. This means each census route will be run once a month. It's fewer routes to cover, but volunteers are still needed. All that's required is the ability to identify Central Illinois river birds, a scope, and a two-hour commitment. The routes can be run any time from Friday morning to Monday evening on the weekend you choose.

Illinois River Birding Trail:

Following the November program on the Upper Mississippi River Birding trail, Peoria Audubon committed to help scope out a similar trail for the Illinois River. A packet outlining the information that needs to be collected is available and an informal brainstorming session will be scheduled next month. Join the effort and share your expertise on the best birding in Central Illinois.

Earth Day/Migratory Bird Day Outreach:

Peoria Audubon would like to be represented at both of these community events. The Earth Day celebration is tentatively planned for the afternoon of Sunday April 21st at Lakeview Park. Migratory Bird Day will be Saturday May 11th at Forest Park Nature Center. At both events, volunteers are needed to staff an Audubon booth, lead bird walks, and more.

Farmdale Bird & Butterfly Inventory:

The Army Corps of Engineers is interested in inventorying bird and butterfly life at its Farmdale site in East Peoria. They also have an extensive bluebird trail in need of both maintenance and monitoring. This may be your opportunity to uncover a new "hot spot" in a relatively unexplored area.

As organizer Marj Tattersall explains, "Even though we added a third boat team from Havana to Beardstown, we were not able to match last year's record of 685 eagles ... but it wasn't from a lack of trying." Thanks to Marj, and boat team organizer Mark Werner, for a great count and a wonderful opportunity to educate all of Central Illinois about the treasures right in our own backyard.

Cooper Park Wetlands Protected

On October 30th, the Illinois Nature Preserves Commission approved registration of the 55-acre Cooper Park Wetlands in East Peoria as an Illinois Land and Water Reserve. Cooper Park Wetlands, within Cooper Park, is located along the eastern shore of Lower Peoria Lake, along State Route 116. Cooper Park is owned by the Fondulac Park District.

There are now 64 registered Illinois Land and Water Reserves totaling 22,759 acres. Areas registered as Illinois Land and Water Reserves are protected from development under a voluntary conservation easement agreement involving the landowner, the Illinois Department of Natural Resources, and the Illinois Nature Preserves Commission. Only areas meeting specific criteria are eligible to be registered as Illinois Land and Water Reserves. Cooper Park Wetlands not only has rare wetland communities such as shrub swamp and marsh, but it also provides habitat for the state and federally threatened decurrent false aster, a plant found only along the Upper Mississippi River and Illinois River Bottomlands Natural Division and in a few locations near St. Louis.

Cooper Park Wetlands is easily accessed by visitors at three entrances: the south entrance to Cooper Park, the middle entrance to Cooper Park, and just south of the Spindler Marina. A gravel trail and boardwalk guide visitors through the natural area. At one point, the boardwalk passes near a series of active beaver dams; the beavers themselves, however, may prove elusive. Multiple visits at different times of year are necessary to fully experience the range of natural biodiversity at this site.
